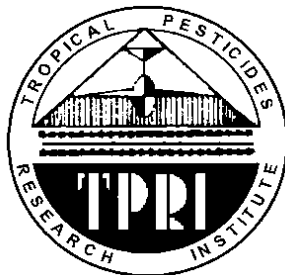

It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the tender for Provision of Air Ticketing Services.
2. The Tropical Pesticides Research Institute now invites sealed Tenders from eligible providers for Provision of Air Ticketing Services under Framework Contracts.
3. Tendering will be conducted through the National Competitive Tender procedures specified in the Public Procurement (Regulations, 2013 – Government Notice No. 446 and its amendment 2016 Government Notice No. 333, and is open to all Tenderers as defined in the Regulations.
